**2026 Full Season Summer Stall Fees**

Summer Full Season (Outdoor):

\*If returning vendors / new applicants pay by Spring Vendor Meeting, the full season fee will be \$300 per stall (returning vendors can sign up 2 stalls if they chose).

\*If returning vendors / new applicants pay after the Spring Vendor Meeting, the full season fee will be \$350 per stall (returning vendors can sign up 2 stalls if they chose).

\*\*All fees must be received prior to the vendor setting up at the first market.

\*\*\*Vendors have the option of turning in a check at the Spring Vendor Meeting and asking the Treasurer to hold (not deposit) the check until the Monday after the first market of the Summer Season.

**2026 Drop-In Summer Stall Fees**

\*The drop-in summer vendor fee is \$40 per Saturday.
